19 The Court, having received and reviewed the parties' briefing regarding Talking
20 Rock Land, LLC's ("Talking Rock") Motion for Entry of Final Judgment, hereby
21 ORDERS:

22 A. IT IS HEREBY ORDERED, granting Talking Rock's Motion for Entry of
23 Final Judgment;

24 B. IT IS HEREBY FURTHER ORDERED, awarding Talking Rock \$86,831.12
25 in attorneys' fees and costs as against Defendant Inscription Canyon Ranch Sanitary
26 District;

1 C. IT IS HEREBY FURTHER ORDERED, awarding Talking Rock post-
2 judgment interest at a rate of 6.50% per annum (\$8.90 per day) on the award of \$50,000 set
3 forth in this Court's final judgment entered on March 20, 2019, which shall accrue from
4 March 20, 2019 until paid;

5 D. IT IS HEREBY FURTHER ORDERED, awarding Talking Rock post-
6 judgment interest at a rate of 5.25% per annum (\$5.30 per day) on the award of \$36,831.12
7 set forth in the Arizona Court of Appeals March 3, 2020 Order, which shall accrue from the
8 date of entry of the Mandate (March 5, 2020) until paid;

9 E. IT IS HEREBY FURTHER ORDERED, awarding Talking Rock post-
10 judgment interest at a rate of 4.25% per annum on the remaining award of \$1,000.00 as
11 reasonable attorney's fees for preparation of the Motion for Entry of Final Judgment and as
12 set forth in the instant Final Judgment, which shall accrue from the date of entry of this
13 Final Judgment until paid;

14 F. IT IS HEREBY FURTHER ORDERED, that no further matters remain
15 pending and this judgment is entered under Rule 54(c), Arizona Rules of Civil Procedure.
